"Election Committee" means a committee appointed by the Cabinet Secretary responsible for agriculture to conduct the elections of miller representatives.	
"Independent parties" means any person who in any way is interested in the elections of the miller representative	
"Miller" means a person currently licensed to operate a sugar mill and has been milling at least for the last twelve months in Kenya for the production of sugar including refined	
sugar and other by-products "Polling Station" means a place or venue designated by the Elections Committee where	
registered and licensed sugar millers shall cast their votes; "Presiding Officer" means a person appointed by the Elections Committee to be in	
charge of the electoral process in a polling station;	
"Voter" means a delegate nominated by a registered miller	
"Voters register" means a register of delegates nominated by a registered sugar miller

(c) Council of Governors (2)			
(d) Independent Electoral and Boundaries Commission (2)			
(2) The Cabinet Secretary shall appoint the chairperson of the committee from among			
members listed in 4 (1)			
(3) The Elections Committee shall appoint the Presiding Officers to preside over the			
election of miller representatives to the Board.			
(4) The Board shall bear all the costs of conducting the elections of the miller			
representatives.			
(5) The term of the Elections Committee shall commence from the date of appointment			
up to the date the elections are concluded.			
(6) Notwithstanding the provisions of clause 4(5) above, the committee may be recalled			
to conduct a repeat election arising from a court order.			
5. (1) The functions of the committee shall be to: -	Functions of		
(a) Conduct free and fair elections of the miller representatives to the Board;	the Committee		
(b) Issue the notice of elections;			
(c) Appoint presiding officer and a clerk for the polling station;			
(d) Designate and review polling stations for the purpose of election			
(e) Organize and conduct elections in accordance with the election procedure;			
(f) Print election materials and supervise the distribution;			
(g) Review and implement the election schedule;			
(h) Prepare and submit a report on the election to the Cabinet Secretary;			
(i) Make recommendations on improvement of election process; and			
(j) Carry out such other functions as may be necessary for the proper conduct of the			
elections.

6. (1) All sugar miller delegates whose names appear in the voters register shall have	Guiding		
the right to vote and to participate in the elections.	Principles		
(2) Election of candidates shall be done through a democratic system of one miller,			
one delegate, one vote.			
(3) The Cabinet Secretary shall declare vacancies for miller representatives to the			
Board and invite millers to nominate one (1) delegate each.			
(4) The Committee shall issue a notice for the elections of miller representatives to the			
Board in Form KSB/ELEC/25/01/A set out in the First Schedule and the election			
scheduled at least twenty one (21) days before the election date and forward a copy to the			
Kenya Sugar Board.			
(5) The notice for the elections and polling station shall be prominently displayed in			
all the sugar factories and KSB website.

(6) The Kenya Sugar Board shall prepare a voter register and submit an accurate and updated copy to the Elections Committee at least twenty one (21) days before the date of elections. (7) The voters register shall be displayed at all the sugar factories and the KSB website to confirm registration at least twenty-one (21) days before the date of elections. (8) The campaign period shall commence twenty one (21) days to the date of the elections and shall end by 5.00 p.m. on the date preceding the day of elections as specified in the notice for the election issued by the Elections Committee. (9) The Elections Committee shall prepare, avail and distribute adequate voting materials. (10) The ballot papers shall be prepared and availed at the venue. Voters shall write the full name of the preferred candidate they are voting for on the ballot paper. (11) The ballot box shall be a transparent container with a seal and an opening at the top to facilitate voting. (12) Before commencement of the voting, the Presiding Officer will ensure the ballot box is empty and properly sealed in the presence of all the delegates. (13) The elections shall be by secret ballot. (14) Elections shall be held between 9.00 a.m. and 5.00 p.m. (15) The Presiding Officer shall announce the results after counting and declare the two (2) elected miller representatives on the same day of the election. Nomination Once the notice of election has been issued, interested candidates shall be required procedure to pay a non-refundable nomination fee of Kshs. 50,000 (fifty thousand only) before the date of election **8.** (1) The nominated candidates shall submit the following to the Presiding Officer; a) Copy of the National Identity card or passport; b) A letter from the sugar factory nominating the voter as a delegate and, must be seconded in writing by another miller c) Proof of payment of non-refundable nomination fees of Kshs. 50,000/= (fifty thousand only). (2) All delegates shall sign Form KSB/ELEC/25/B set out in the First Schedule in which they commit to adhere to the election procedures as well as the candidacy requirements. (3) The Presiding Officer shall cause to be displayed names of the nominated candidates at the venue of the election. Eligibility of 9. (1) A person shall be eligible to vie for elections of the miller representative to the candidate(s) Board if that person is: vving for a) A nominee of a sugar miller eligible to participate in the election; elections b) A Kenyan citizen or a holder of a valid work permit; c) Meets the requirements of Chapter six (6) of the Constitution on leadership and integrity (Duly filled and stamped Ethics and Anti-Corruption Commission (EACC) self- declaration form, Credit Reference Bureau Certificate, Tax Compliance Certificate, Police Clearance Certificate) d) Payment into the Kenya Sugar Board account a non-refundable fee of Kshs. 50,000/= (fifty thousand only).

10. (1) A voter shall on the date of election present the following documents to the Presiding Officer for verification: - (a) National Identity Card or Passport; (b) A letter from the sugar factory nominating the voter as a delegate	Voting process

(2) The Presiding Officer shall verify the voters' documents and identity to confirm	
their eligibility to vote.	
(3) A voter shall cast their vote by writing the full name of the preferred candidate	
on the ballot paper.	
(4) Upon voting the polling clerk shall strike out the name of the voter from the	
voters' register using a red inked pen.	
(5) A voter shall be accorded privacy during the voting exercise.	
(6) Any ballot that is spoilt by the voter or election official shall be clearly marked as spoilt and submitted to the Presiding Officer.

(2) The Presiding Officer shall conduct a thorough investigation on the complaint and determine the matter.

(4) Upon recording the number of votes cast, the Presiding Officer shall request	
the nominees to append his or her signature in the form.	
(5) The failure or refusal by the nominees to endorse the form under clause 12 (4),	
shall not invalidate the results.	
(6) The Presiding Officer shall announce the results of the voting and declare the	
winner and issue election certificate in Form KSB/ELEC/25/D set out in the First	
Schedule, at the polling venue before submitting the results to the chairperson of the	
Elections Committee.	
(7) The Presiding Officer shall as soon as practicable (but not later than a day),	
deliver the ballot boxes, counted ballot papers, rejected, spoilt, disputed ballot papers and	
the results of the voting at the polling venue to the Chairperson of the Election	
Committee who shall take charge thereof.	
(8) The Elections Committee shall ensure safe custody of the ballot papers and	
voting materials after the election for at least six (6) months for reference in the event of	
a dispute.	
(9) The Chairperson of the Elections Committee shall present the names of the	
elected miller representatives to the Cabinet Secretary for confirmation and appointment	
as directors within seven days (7) days of the elections.

13. (1) Independent parties shall apply to the Elections Committee to become	Election

(2) The Committee shall consider and accredit observers for the election of miller	

representatives.	
(3) The role of the observer shall be to monitor the conduct of elections, take note of any election irregularities that may arise or that may need to be addressed in elections and make recommendations that may further enhance the credibility of elections in future.	
(4) An observer shall not be a grower or a miller and shall NOT participate in or interfere with the elections.	
(5) An observer(s) shall submit a report on the elections to the Elections Committee	
14. (1) The Cabinet Secretary shall constitute a Dispute Resolution Committee to consider and determine disputes arising from the electoral process. (2) The Election Dispute Resolution Committee shall comprise the following members; (a) A chairperson appointed by the Cabinet Secretary who is a qualified/licensed arbitrator (b) A person nominated by the Council of Governors (CoG) (c) An officer from the Elections Committee. (d) A person with legal knowledge/qualifications nominated by the Chairperson of the Law Society of Kenya. (e) One person nominated by the Cabinet Secretary from the ministry in charge of agriculture (f) The secretary to the Committee shall be a representative from the Kenya Sugar Board who shall be an ex officio member.	Dispute Resolution
(3) The quorum for conducting the business of the Election Dispute Resolution Committee shall be two-third (2/3) of the members. (4) The Chairperson shall preside at every meeting of the committee at which he/she is present and in his/her absence, the members of the committee present shall elect one of their members to preside, who shall, with respect to that meeting and the business transacted thereat, have all the powers of the chairperson. (5) Unless a unanimous decision is reached, a decision on any matter before the committee shall be by a majority of the votes of the members present and voting and in the case of an equality of votes, the chairperson or person presiding over the meeting shall have a casting vote. (6) The Election Dispute Resolution Committee shall be appointed by the Cabinet Secretary at least fourteen (14) days prior to the date of the elections. (7) In performance of its functions and subject to the provisions of these procedures, the Election Dispute Resolution Committee shall regulate its own procedures. (8) The term of the Election Dispute Resolution Committee shall commence from the date of appointment up to the conclusion of the election. (9) This notwithstanding, parties are encouraged to solve the disputes amicably
